State Assessment:

As mandated by the Ohio Board of Building Standards;

Residential Permits are subject to State of Ohio 1% Surcharge

Commercial Permits are subject to State of Ohio 3% surcharge.

These fees are due and payable at the time of application with application fees.

Example #1: <i>New Electric Permit for <u>Commercial</u> Building</i>	\$ 150.00
<i>State of Ohio 3% surcharge</i>	<u>4.50</u>
<i>Total due with application</i>	<i>\$ 154.50</i>

Example #2: <i>Replacement <u>Residential</u> HVAC - Heat & A/</i>	\$ 90.00
<i>State of Ohio 1% surcharge</i>	<u>.90</u>
<i>Total due with application</i>	<i>\$ 90.00</i>

Note: Unspecified Permit Fee - for any permit type, not specifically listed in this Fee Schedule, the fee shall be calculated to the most similar permit type at the discretion of the Building Official.

Note: "Minimum Base Fee" is a non-refundable deposit due at time of application.
