A RESOLUTION: DECLARING THE NECESSITY OF LEVYING A NEW CONTINUOUS FIRE AND

EMERGENCY MEDICAL EXPENSE TAX IN EXCESS OF THE TEN-MILL LIMITATION AND REQUESTING THE COUNTY AUDITOR TO CERTIFY

MATTERS IN CONNECTION THEREWITH; as amended

WHEREAS, the amount of taxes that may be raised within the ten-mill limitation will be insufficient to provide for the necessary requirements of this city; and

WHEREAS, it is in the best interest of the City to issue a new continuous tax at a rate of 2.0 mills for fire and emergency medical expenses that provides critical revenues needed to operate the City; and

WHEREAS, pursuant to Section 5705.03 of the Ohio Revised Code, the City of Englewood is required to certify to the county auditor a resolution requesting the county auditor to certify certain matters in connection with such a tax levy;

NOW, THEREFORE, BE IT RESOLVED BY AT LEAST A TWO-THIRDS VOTE OF THE COUNCIL OF THE CITY OF ENGLEWOOD, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:

SECTION I The City of Englewood, in accordance with ORC 5705.03(B), requests the

Montgomery County Auditor to certify the current total tax valuation of the City of Englewood, entirely located in Montgomery County, and the dollar amount of revenue that would be generated by a 2.0 mills additional

continuous levy.

SECTION II This is necessary that the tax be levied in excess of the ten-mill limitation

for the purpose of operating and maintaining the Fire and EMS department

and all other purposes authorized by ORC 5705.19(I).

SECTION III The question of passage of said new tax levy shall be submitted to the

electors of the City of Englewood at an election to be held on November 5, 2019. If a majority of the voters voting on this new levy vote in favor thereof, this levy shall be first placed on the tax list and duplicate for the tax

year 2019, for collection in calendar year 2020.

SECTION IV

Pursuant to Section 5705.03 of the Ohio Revised Code, the County Auditor is hereby requested to certify to the City of Englewood the total current tax valuation of the City and the dollar amount of the revenue that would be generated by the number of mills specified in Section I hereof, and the Clerk is hereby authorized and directed to certify a copy of this resolution to the Montgomery County Auditor immediately upon its adoption.

SECTION V

That this Resolution shall be in full force and effect at the earliest date allowed by law.
