**A RESOLUTION: AUTHORIZING THE SUBMITTAL OF A CDBG APPLICATION WITH MONTGOMERY COUNTY SEEKING FUNDS TO CONSTRUCT AN ADA COMPLIANT BASEBALL PLAYING SURFACE AT CENTENNIAL PARK**

**WHEREAS**, federal criteria for Community Development Block Grant (CDBG) funds include physical improvements in compliance with the Americans with Disabilities Act (ADA); and

**WHEREAS**, the city of Englewood is desirous of utilizing such CDBG assistance to improve the Englewood Little League ball field number two by the addition of a turf infield to assist persons with disabilities have access to the field at Centennial Park, located on Union Boulevard; and

**WHEREAS**, the city of Englewood is requesting \$75,000 in CDBG funds to assist with installation of an ADA compliant surface which is estimated at \$150,000.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, COUNTY OF MONTGOMERY, STATE OF OHIO, AS FOLLOWS:**

**SECTION I** That the City Manager be herewith authorized to act, and designated as the official representative of Englewood, in conjunction with all aspects of the preparation, filing, provision of information, and submittal of documentation necessary for participation in the federal CDBG application and funding process, administered by Montgomery County, Ohio, all such activities being necessary to secure funding to create an ADA compliant surface and access to a Englewood Little League baseball field at Centennial Park.

**SECTION II** That City Council hereby understands and agrees that participation in the Program will require compliance with program guidelines and assurances.

**SECTION III** That City Council hereby commits itself to provide matching funds as described in the application, and authorizes the City Manager to expend those funds if necessary.

**SECTION IV** It is hereby found and determined that all formal actions of this council concerning and relating to the passage of this resolution were taken in open meetings of this council, and that all deliberations of this council and/or any


committees that resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements.


