



DESCRIBE WHAT HAPPENED

At about 1105 on September 12, 2021, unit 1 was in the parking lot of 9295 N. Main Street (Waffle House) heading west. Unit 1 struck a yellow concrete barrier that is in front of the Waffle House entry door lobby area, causing structural damage to the building. Unit 1 then put the vehicle in reverse heading east and hit unit 2 which was parked in the parking lot of Waffle House. Unit 1 sustained moderate damage to the front bumper and the drivers side rear bumper area while Unit 2 sustained light damage to the drivers side bumper.
