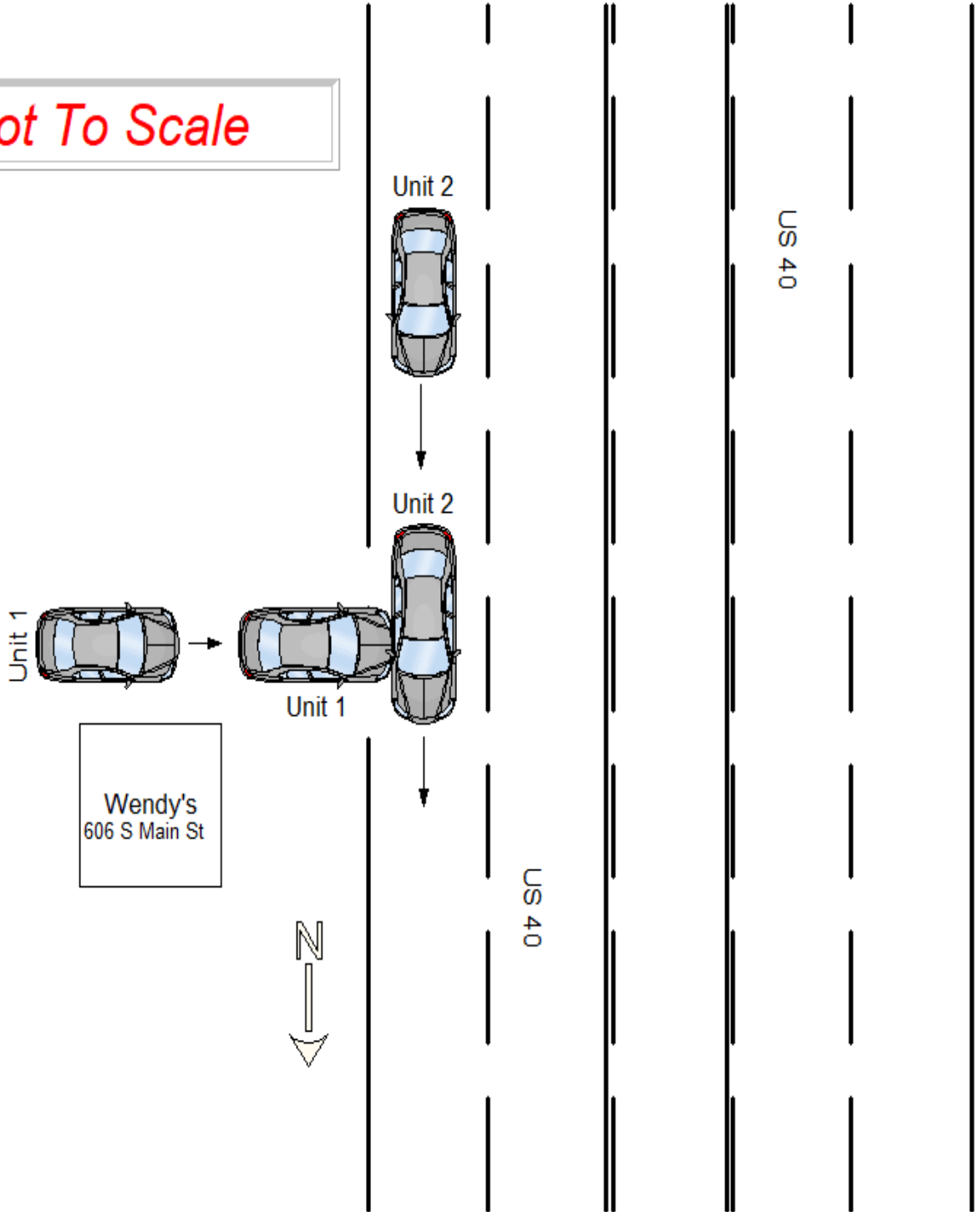

Unit 2 began to follow unit 1 as they made a right turn on Woodside Drive, a left turn on Winnimac Avenue, and then a right onto Taywood in order to get a license plate for the vehicle. Unit 1 continued West onto W. Wenger Road and turned South onto Union Blvd. Unit 2 was unable to keep up with unit 1 once they reached Union Road at W. National Road due to unit 1 proceeding to go through the red light. Unit 2 then proceeded to the Kleptz YMCA parking lot located at 1200 W. National Road, Englewood, Ohio where she was instructed by Englewood Dispatch.

Union Police Department responded to the address of unit 1, which came back to 510 Sheets Street, Union, Ohio where they made contact with the driver. The driver of unit 1 stated that he left the scene because he was scared. The driver of unit 1 also stated that he left after striking unit 2 due to the fact that he does not have insurance on the vehicle.
