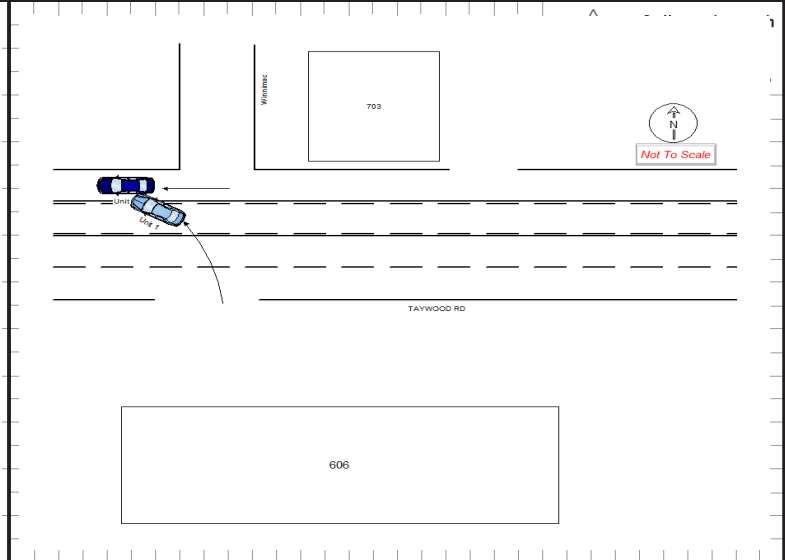

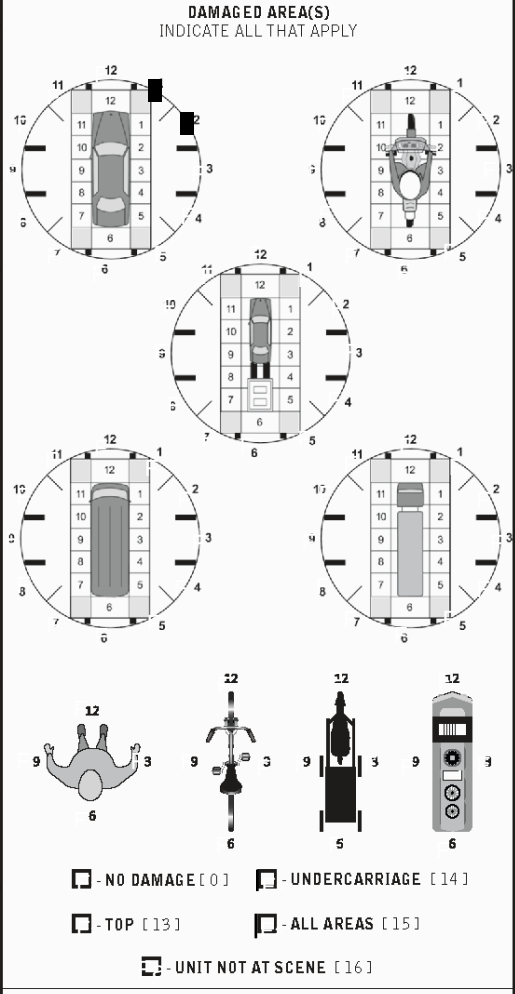

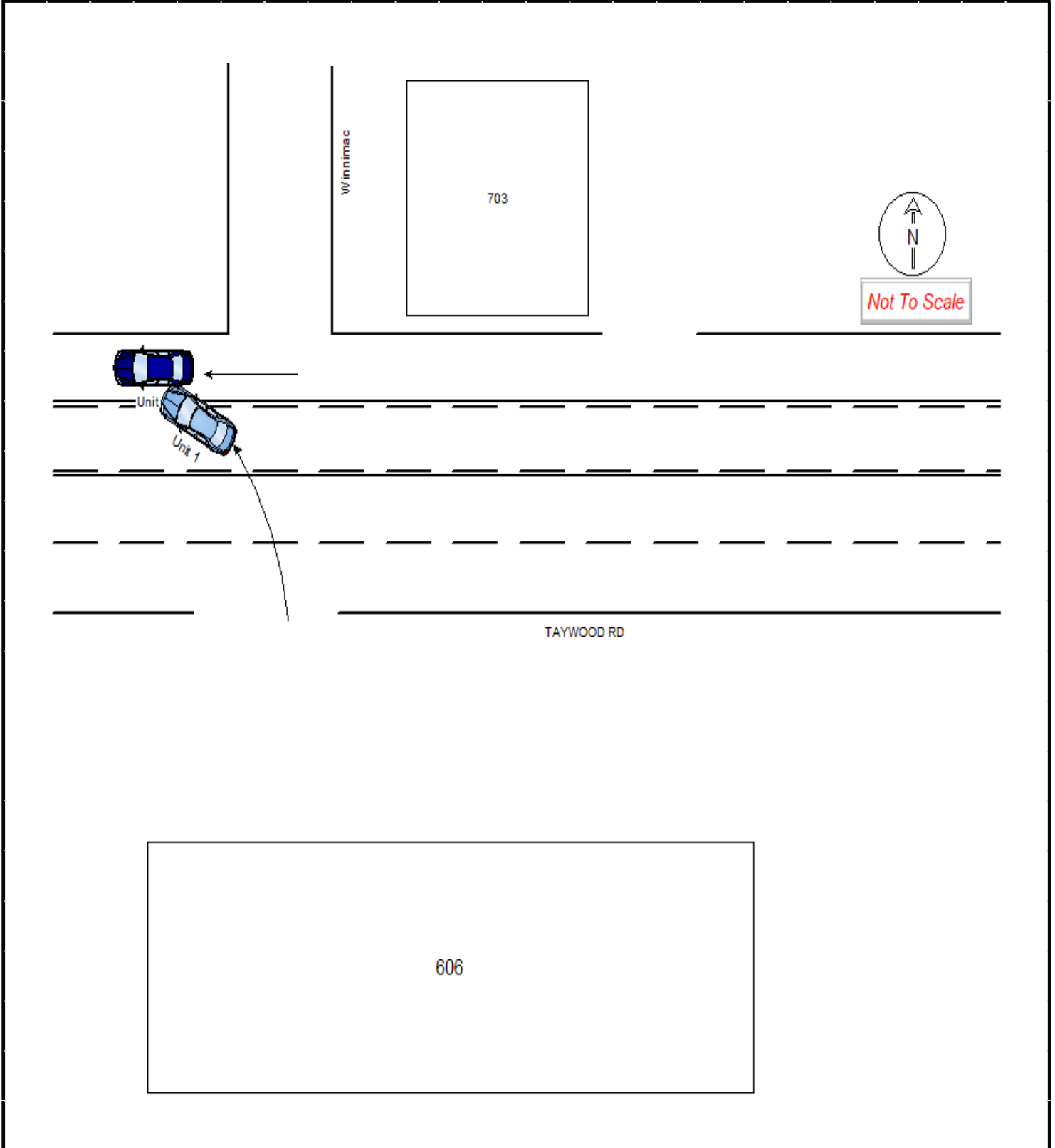

The driver of unit 1 initially stopped and provided her name "Janohn Walker" and phone number (9379609068.) I searched that name in LEADS and found only one entry with that first name. Her address was listed as 711 W Wenger Rd APT 141. I asked the driver of Unit two, Christina Packard, if the picture I had pulled up was the subject from the crash. She stated she wasn't sure and explained that the woman had her hair pulled back and had glasses on. This subject did have a restriction on her license that she must have corrective lenses.

Packard advised unit 1 was a Ford passenger car, possible Fusion, and was a gray/blue color. She stated the female was not acting "right" and thought something might have been going on with her. Packard advised the woman stated she would pay her for the damages, but she told her she needed to file a police report. She stated she picked up her phone to call the police and the female got into her vehicle and fled on Taywood, towards Wenger.

I responded to 711 W. Wenger Rd. and did not locate the vehicle. I checked the apartment complex and did not locate it either. I made contact with Walker at apartment 141. I asked her if she had been involved in a crash and she stated she had. She explained she was in the Planet Fitness lot (606 Taywood Rd) and was stopped at Taywood Rd on the private drive. Walker advised she proceeded to turn left and collided with another vehicle. She stated she exchanged information and Packard told her she would call her if she needed anything else. I asked her if she had insurance on her vehicle and she stated she did not have insurance. I asked her where the vehicle was and she stated it was in Dayton. Walker advised the vehicle was not registered to her yet, and belonged to an insurance company.

I explained to Walker that it is extremely important be cooperative. I provided her a Form 36 and advised her to get the vehicle information to me as soon as possible. I told her that she would be cited for the cause of the crash, but could potentially be cited for leaving the scene as well. Walker advised she would get the information to me tomorrow (11/7.)

I attempted to contact Walker on 11/7, 11/8, 11/9, and 11/10 with no luck. I also left two voice messages with the number she provided and have not received a response. Due to Walker avoiding contact, I left a form 36 and a copy of the citation with a pay out slip under her door. I also posted one to the front of her door.

Since I do not have vehicle information, the citation has limited information for the vehicle section.
