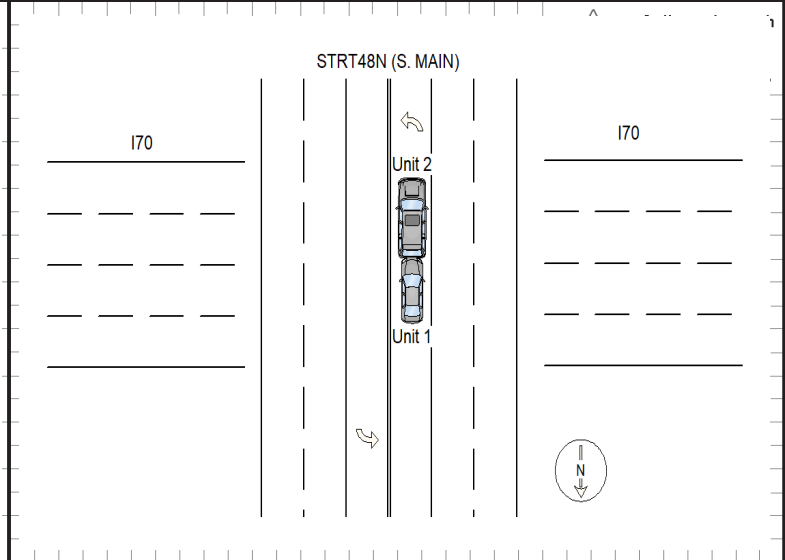

At about 1734 hours on November 26, 2021 unit 1 was traveling South on State Route 48 (S. 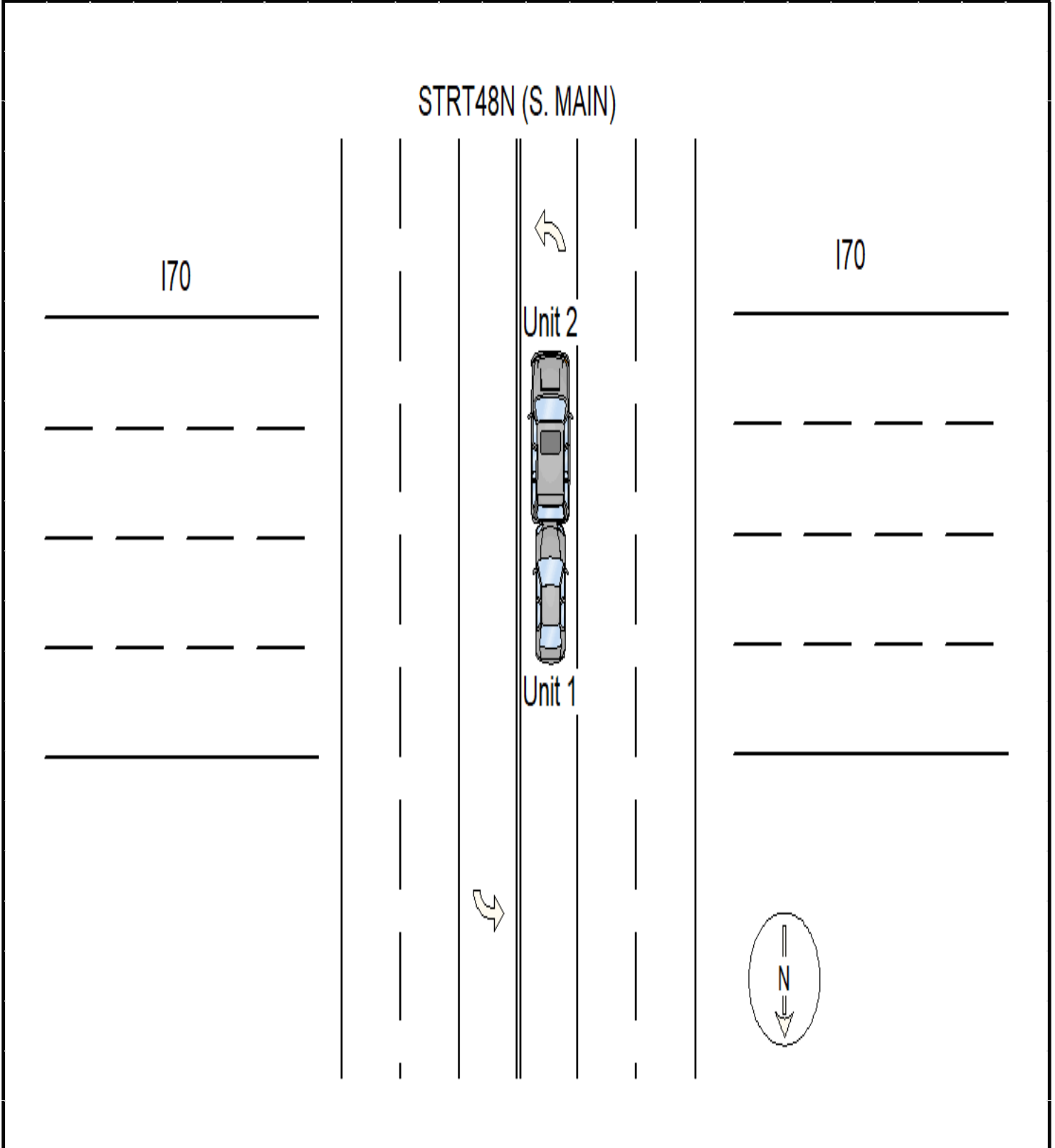
