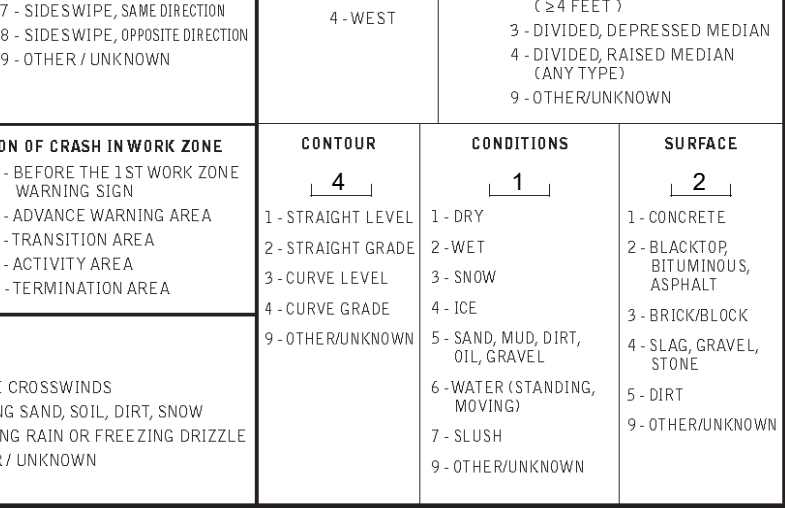

 On 12/24/2021 around 1020 hours, Unit 1 turned west onto W Wenger Rd from St. Rt. 48 using the left lane. Unit 1 traveled outside of their lane as the roadway curved, causing Unit 2, in the right lane beside Unit 1, to travel outside of their lane to avoid a collision. Unit 2 struck the curb with their right front rim causing scuffs to their rim.

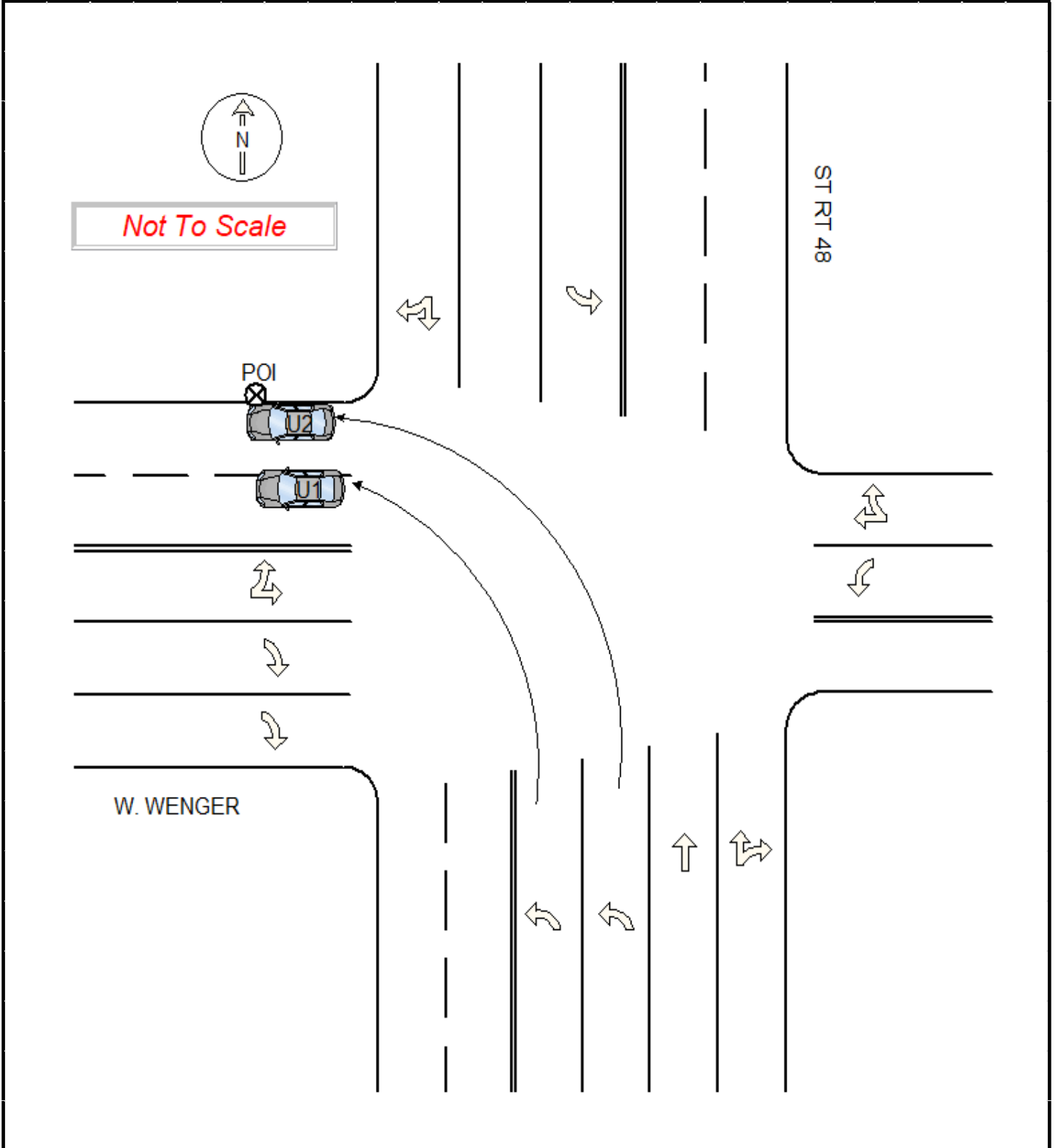

On 12/24/2021 around 1020 hours, I was dispatched to Incenta FCU, 175 W Wenger Rd, Englewood, OH 45322 for a crash that had occurred on W Wenger Rd.

Unit 1 turned west onto W Wenger Rd from St. Rt. 48 using the left lane. Unit 1 traveled outside of their lane as the roadway curved, causing Unit 2, in the right lane beside Unit 1, to travel outside of their lane to avoid a collision. Unit 2 struck the curb with their right front rim causing scuffs to their rim.

There was a language barrier with the driver of Unit 1, and they were unable to tell their side of the story. Unit 2 provided the details of the encounter. Due to the minor scuffs to the right front rim of unit 2's vehicle and the lack of evidence of involvement, I did not issue a citation to either unit.

I explained to both units that I would prepare a crash report and collected their information. Both units were provided a report number to obtain a copy of the report.

I reviewed the city camera footage, but could not find footage of the encounter.
