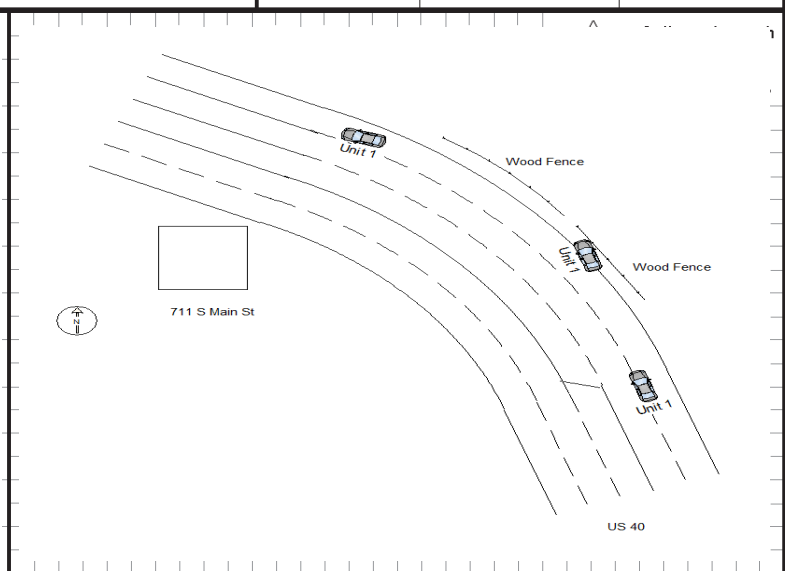

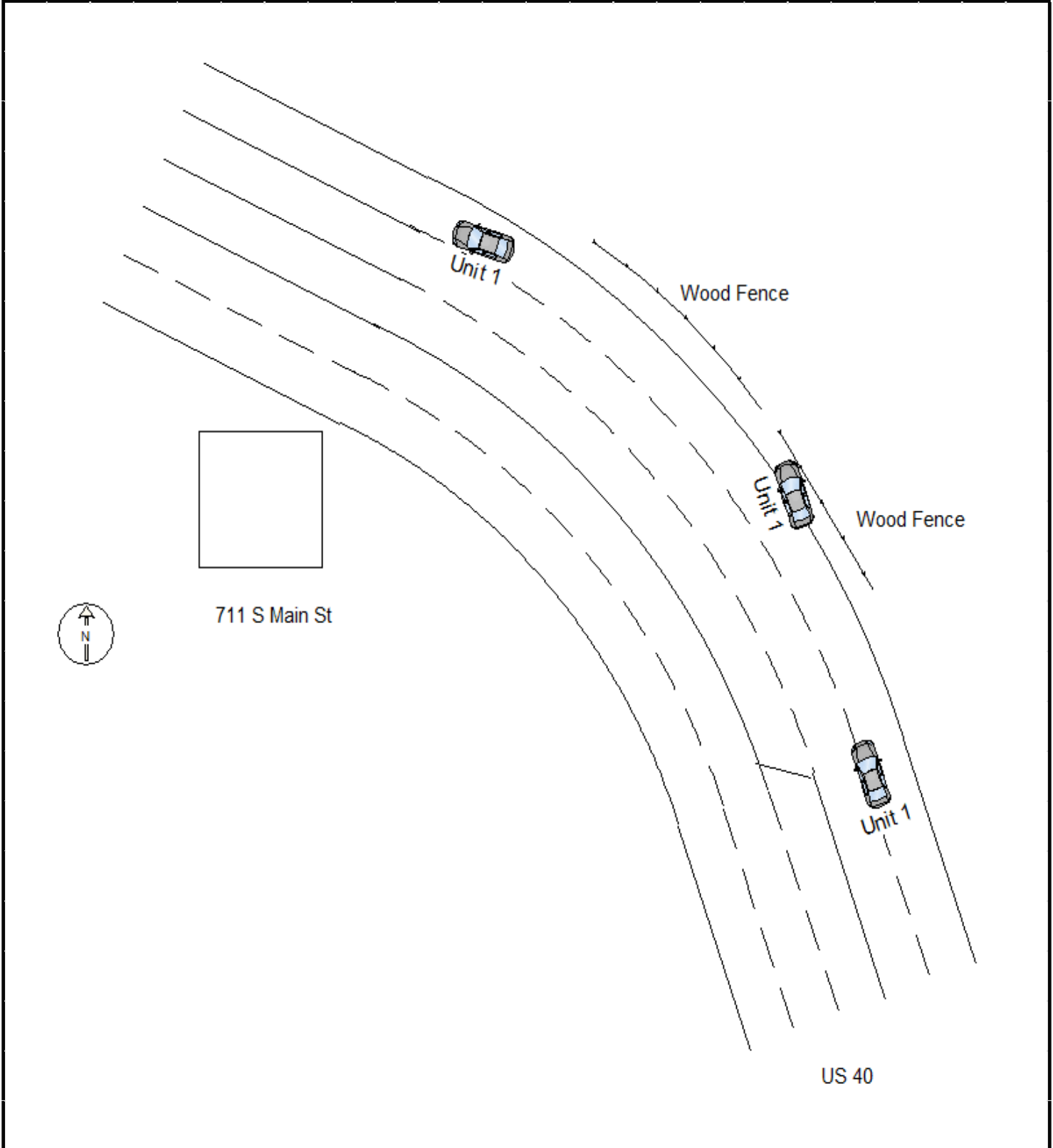

Officer Ricker went to the intersection of US 40 at Taywood Rd. He observed the curb on the east bound side, which appeared to have rubber marks down the side of the curb. Officer Ricker observed a wood fence that appeared to have red plastic pieces by it from a taillight. McCorkle's right taillight and both tires on the passenger side were blown out. I later looked at the city cameras at the time McCorkle would have entered the intersection. I observed McCorkle come around a turn right before the intersection and it appeared he swerved to the right and went out of the camera view but was in the area where the markings on the curb and the pieces of the taillight were. McCorkle then stopped several feet north of the markings on the curb, appearing to be assessing his car from the damage to it. Photographs were taken of McCorkle's car and the wood fence, and were added to P1. This incident was investigated after McCorkle was incarcerated for OVI, so no citation for this incident was given.
